I was assigned to this case as the lead investigator. The case involves a request to investigate possible voting or voter registration violation from the Hennepin County Elections Office.

The request stated that Nathan Shea Pingry submitted registered and voted in Minneapolis W-5 P-07 in the 2020 General. Violation type: Felon EDR.

The request to investigate was added to this case.

I have checked multiple sources during the course of the investigation to determine if S/Pingry is in violation.

I have checked MNCIS and the DOC portal (Statewide supervision System). MNCIS shows that S/Pingry has multiple convictions ranging from Misdemeanor to Felony. However, SSS shows that S/Pingry is not currently on probation for any of those offenses.

S/Pingry was currently on probation on multiple cases, one in Stearns County which was fulfilled on 06/11/2020, one with Hennepin County which was fulfilled on 07/20/2020, one with DOC which was fulfilled on 07/15/2020 and one listed with Ramsey County fulfilled on 03/19/2020.

The alleged crime occurred on 11/03/2020.

At this time it appears that S/Pingry has fulfilled his commitment with probation and does not appear to be in violation on the date/time of the listed offense for voting.
