STATEMENT OF SERGEANT NIMLOS BADGE #5138

On 09-08-21, I (Sergeant Nimlos) was assigned as lead investigator to this case involving the listed suspect regarding voter registration violations from the Hennepin County Elections Office. The request from Hennepin County stated that Suzette Jordis Gilreath DOB [REDACTED] violated voting law by double voting.

During the 2020 general election Suzanne (Suzette) Jordis Gilreath mailed in a ballot for voting in Minneapolis W-8 P-04 and registered and voted in person in Minneapolis W-8 P-04. I was requested to investigate possible voting or voter registration violations.

During the initial investigation, I checked multiple sources to determine if S/Gilreath is in violation. I checked MNCIS and DOC portals (statewide supervision systems) MNCIS showed Gilreath with only numerous traffic violations. The DOC portal (statewide supervision system) showed that S/Gilreath was not on probation.

On 10-13-21, I contacted Suzette Gilreath by phone and recorded the conversation. S/Gilreath confirmed the over the phone that she is the listed suspect. She agreed to talk to me about the voter fraud case. I learned that she remembers voting in person near her house in Minneapolis but doesn't recall voting by mail. She didn't intentionally vote twice and doesn't remember voting though the mail. The phone interview was recorded on Olympus recorder and saved under job file 104239
